- {10} Continued game. ½ fee if you return. New umpires will get full fee.
- {11} Call School to confirm you game especially on bad days.
- {12} Tournament Requirements: There were many reason given for not getting tournament games. All semi and finals are done by AA. A officials got Pre and Quarters B umpires go Pre and Quarters.

Fee for tournament: \$94 for Pre and Div 3 first round. \$94 for quarters \$106 for Semi and Finals There were 138 possible umpires for 2014 tournament. 33-AA 23 A 31 B {after checking all NHSUA requirements. 87 Umpires got games in 2014 tourney.

{13} Softball Committee: Get to games ½ hours before start, Hustle on an off field, Work with coaches, 12 run rule, Must go 5 innings unless 4 ½ home team winning, coaches attire, check bats, consistent strike zone, Consistent on calling illegal pitches, work with your partner, know the concussion rule, stop chanting while pitcher is set, think about conflict of interest, read NHIAA policies,

{14} Emphasis: Keep hard copy of line-up card, Lightning and Thunder 30 MINUTES FROM LAST SEEN OR HEARD, disqualify to bench first, give more time when bus is late, let supervisor know about bad fields and problems with AD's, have good game control, know your rules, communication with partner, use good judgment - remember it is about the game and get it played, any protect, ejections or contact you need to fill

out form and contact Pierre.
