1. Protests should be reported to both myself and Al Douglas. Al should be called forprotests first, but you need to call both of us. If the winning team is protesting and doesnot want to file after the game, you must still contact me to make a report. Avoidproblems by reading the rulebooks. Correct procedures—protest must be made before the next pitch. Sign off on both books at time of protest and note the time of theprotest. If teams are protesting the field conditions, fix it if you can. Once the game isstarted it must be played if it can be. It is not protest able if you start the game.

2. Ejections and physical contact must be reported to me the day of the ejection orphysical contact, so I can report it the next day to NHIAA, and to let the schoolsknow.

3. Fees—For the next two seasons Varsity \$90 JV \$70 Over 40 miles \$14---80 miles \$24

Scrimmage rate is the JV rate--\$70 If you are doing a doubleheader, it is \$10 less.

Playoff fees First 2 rounds \$100 Semi and Final Rounds \$112

The new structure which was approved (starting 2023-2024) increase the fees to \$83 and \$63 with a new travel allowance based on one-way travel 0 - 20 miles add \$10 21 - 40 miles add \$20 41 - 60 miles add \$30 60 +miles add \$40

So, when you travel 43 miles one way and do a varsity game, fee paid is \$113 if also a Sub-V, then \$176

9. Playoffs—Some umpires did not get games last year because you opted out for

COVID. The softball committee told me to only use AA and A umpires in the first2 rounds unless I had to use B umpires and, in the semi, and final games only AA umpires unless A's are needed. I have petitioned the Sport Officiating Committee to allow us to use a three-person system during the first round of the playoffs also, but with baseball not using three for every round now I am not sure what NHIAA will recommend now. Last season, I used 66 umpires in the playoffs.

10. Please put your picture on the Arbiter. It would be good for your partners to know who they are umpiring with if they do not know you. Make sure all your phone numbers are correct on the Arbiter.

11. Tournament requirements—attend an interpretation meeting, pay your dues, attend a 3-man clinic, do a minimum of 7 varsity games, and pass the test.
